SAFA NON-PROFESSIONAL FOOTBALL RETURN TO PLAY CONSENT, INDEMNITY & UNDERTAKING FORM

I knowingly and willingly consent to attend FOOTBALL training and SAFA matches as permitted under the current Regulations at **CAMPS BAY FOOTBALL CLUB** (team)

- I understand the COVID-19 virus has a long incubation period during which carriers of the virus may not show symptoms and still be highly contagious.
- I understand that due to the frequency of visits of other players, the characteristics of the virus, and the characteristics of football activities, I have an elevated risk of contracting the virus simply by being at a football training and match venue.
- High risk people include persons over the age of 60, persons who have pre-existing medical conditions such as: asthma, chronic lung conditions, hypertension, autoimmune disease, organ transplants, cancer, immunocompromised, obesity (BMI over 40) and liver or kidney disease conditions. I confirm that I do not fall into any of these high-risk categories.
- I acknowledge that if I have been diagnosed with COVID-19 or suspected of having COVID-19, a letter from a medical doctor confirming that I am fit to return to train & play; and that I have completed the 10 days quarantine period must be submitted to the Compliance Officer of the (Association/Club/Academy/Team) prior to being permitted back to training.
- I understand that should I have or develop a pre-existing condition which increases my risk, or if I have been in contact, or in future come into contact, with a person who has been diagnosed with COVID-19, that I need to declare this to the Compliance Officer of the (Association/Club/Academy/Team) before I present myself at any training or match venue. I acknowledge that the Compliance Officer is entitled to require that I self-isolate for a 10 days period and/or that I do not participate in any or all football activities at the (Association/Club/Academy/Team).
- I am aware of the risks involved with the spread of COVID-19 and the risks it may hold to my health and the health of others I come in contact with.
- I shall comply with the "SAFA COVID-19 Health & Safety Directive for NONPROFESSIONAL", including the Government Gazettes of 6 July; 28 August; 7 October 2020, 27 June 2021 and 25 July 2021 (where applicable) at all times.
- I accept all of the above risks and conditions and indemnify and hold SAFA, Clubs affiliated to SAFA and their staff including the Compliance Officer harmless against any loss, cost, claim or liability arising as a result of my failure to comply with the Association/Club/Academy/Team to comply with the conditions herein.
- I accept all of the above risks and conditions and hereby indemnify and hold the South African Football Association and All clubs affiliated to SAFA and their staff including the Compliance Officer blameless should I contract the disease at any football training or match venue.

I undertake that I will abide by all the regulations and rules for participation in football as laid out in the "**SAFA COVID-19 Health & Safety Directive for Non Professional Football**", including the Government Gazettes of 6 July; 28 August; 7 October 2020, 27 June 2021 and 25 July (where applicable), a copy of which I have received and read.

I have read and understood the terms of this consent, indemnity and undertaking as laid out and confirm I will comply therewith in full.
